# 10/158 COUNTY & DISTRICT COUNCILLORS REPORTS

The cost will be £ 35 per week plus consumables. Lancaster City Council will provide £ 2,000 per annum payable in full in April towards the Parish Council continuing to provide this facility for the public. Simply Clean had commenced cleaning on April  $1^{st}$ .
