#### 10/269 APOLOGIES FOR ABSENCE:

Councillors Dr DB Coltman, P Marshall and M Williams, PC Carl Wood and County Councillor Mrs S Charles sent their apologies.

#### 10/270 OPEN SESSION

Members of the public attended to put forward their views with regard to the second Planning Application for a reduced number of turbines at the Claughton Moor Wind Farm Project. It was pointed out that some of the turbines will actually be within the Caton-with-Littledale Parish boundary and the Parish Council was again urged to put in a strong objection to the proposal.

Mr Anthony Dalby gave a presentation on the work of the Lune Valley Rural Housing Association. The Association was founded in 1989 and has 77 properties (2 in Caton) and use Adactus as their Managing Agents. The Board is composed of volunteers and set policy, strategic direction and financial controls. Average rents are £ 80 per week and all homes are to 'Decent Homes' standards. There are concerns that local people get the vacancies when they occur and vacant properties will be advertised with Estate Agent type boards.

The Association produced a small surplus last year but the availability of Grants is limiting the ability to invest in more properties. The Association is encouraging tenants to get involved in the community.
