09/102 OPEN SESSION

09/103 MINUTES OF THE PREVIOUS MEETING HELD ON 9th December 2008

The minutes of the previous meeting held on 9th December were confirmed and signed as a correct record.

09/104 POLICE AND COMMUNITY TOGETHER (PACT).

There had been twelve reports of juvenile nuisance and two crimes reported – an attempted break-in of a car and a wing mirror knocked off.

There were no details of the accident with the War Memorial wall which was believed to have happened around 02:00 on 26th December.

A Neighbourhood Watch group was being set up on Brookhouse Road following previous disturbances.

PC Carl Wood was introduced as the replacement Officer for Keith Collins who is presently off sick but is due to retire shortly.

The Boxing Club is nearly finished and ready to open - just waiting for a gas supply.

09/106 COUNTY & DISTRICT COUNCILLORS REPORTS

The City Council Budget was being prepared but they need to find cuts of £ 1.8 million. 'Special expenses' category has been abolished, however a Task Group has been set up to look into future funding of 'dual expenditure' items by Parish Councils.

Consultation on the proposed closure of Hornby High School. There were to be a number of meetings – 20th Jan. Lancashire Local and 28th Jan. City Council Overview and Scrutiny. It was agreed that we should support the original three year plan for the School, to give it a chance to settle down and Councillors were urged to write to their MPs, Councillors etc.

09/107 LENGTHSMAN, HIGHWAYS & FOOTPATHS

The work of the Lengthsman was discussed and it was agreed that the Property sub-committee would consider what he should be asked to do. They would also consider the areas of grass to be cut under the City Council contract and the cleaning of the bus shelters

A couple of bits of pavement by the Ship Inn require cleaning. Prices would be obtained for the repair of the pot-holes on Station Road car park.

09/107 BUDGET AND PRECEPT

Lancaster City Council has removed the Special Expenses category which means that Parish areas will pay the same as 'City' areas but will have to pay their Parish Precept on top of this. As previously noted a Task Group has been set up to look into alternative funding for Parishes.

The Budget for 2009/2010 was agreed and a copy is attached for information. It was resolved in accordance with Section 50 of the Local Government Act 1992 that the Budget requirement for the Parish was:-

09/113 ACCESS RIGHTS ALONG STATION ROAD

The Environment Agency wish to renew their access rights along our part of Station Road, in connection with the river gauging station and weir on the river Lune. They have proposed Annual rent of £25 per annum for 30 years or a one-off payment of £250. The Clerk was asked to go back and request a ten year term at an annual rent of £25 and consideration of a contribution to the maintenance of the road.
