10/106 COUNTY & DISTRICT COUNCILLORS REPORTS

The District Council had held Public Consultations on their budget proposals. This had been a positive exercise with over 300 taking part. A restructuring of personnel is being undertaken to save money.

The Parish Review Task Group has met and it seems double taxation is 'not' a problem. Parishes are enhancing services. A copy of the report will be requested.

10/107 LENGTHSMAN, HIGHWAYS & FOOTPATHS

Proposed parking restrictions on Brookhouse were tabled for comment. Various suggestions will be put to Highways for their consideration.

It was reported that repairs to erosion on the footpath by the Artlebeck will be undertaken in Spring.

Comments regarding Highway gritting, or lack, of were made. It was agreed to write to County and express our concerns so they can be considered by the Scrutiny Task Group. It was suggested that grit bins should be more available and gritting in front of shops considered a priority.

Councillors agreed that the Christmas Tree and Lights were a success this year., Switch on was performed by Mr J Hall.

It was agreed that we continue with the City Contracts Services for grass cutting in the Village this year Total Cost £ 1,548.00 plus Vat. Maintenance of Fell View equipment will be continued on a two monthly cycle until the hopefully refurbishment is undertaken.

10/108 VILLAGE TOILET

Lancaster City Council are consulting on the Parish Council taking over responsibility for the cleaning etc. of the Village Toilet. They have offered (!) \pm 2,000 towards the cost. The Parish Council will obtain prices for undertaking the works (combined with Vict. Inst. cleaning) and get an official 'offer/contract' from Lancaster City Council.

10/111 PARISH TRANSPORT PROJECT.

County are being chased with regard to the illuminated timetable and bus stop poles etc.

LCC are investigating the new sites on Quernmore Road and Caton Green Road and a report with recommendations will be provided.

10/112 FELL VIEW

The new lease from Lancaster City Council was agreed and a final version for signing would be requested.

The Funding applications had achieved significant success. Stage 1 Funding from Community Spaces for \pounds 50,000 had been secured and a 'Facilitator' appointed. Tom Fison will work with the group to finalise the Stage 2 Application which must be in within 6 months. Planning Approval and all matched funding must be secured by this time.

Parish Council would consider acting as the 'Accountable body' with regard to the finance. They must be in a position to pay invoices and claim Grants from the Funders.

Progress is being mad on consultation with residents and the Planning Application should be submitted by the end of January to meet the tight time scale.

It was agreed the Parish Council would write a letter in support of SELRAP's aims to reopen a cross Pennine rail link from Skipton to Colne.
