12/185 MINUTES OF THE PREVIOUS MEETING HELD ON 8th May 2012

The minutes of the previous meeting held on 8th May 2012 were confirmed and signed as a correct record.

12/186 POLICE AND COMMUNITY TOGETHER (PACT).

Pc Andy Massingham introduced himself as the Officer who was currently looking after Caton and the Lune Valley in the absence of PC Carl Wood.

He reported that there had been a burglary from the Caton Sports association outbuildings and three thefts including one of cattle taken from a farm. There had been an incidence of criminal damage further up the Lune Valley. Youths had been causing problems at the Brookhouse Methodist Church and at the Play Park. This would be investigated and follow up visits made. The Public were encouraged to report all incidents, however minor, to enable the Police to build up a better picture – They are unable to provide resources if no crimes/incidents are reported. Incidents of speeding round Fell View would be looked into and Pc Massingham would provide a presence. A request for speed calming measures would be pursued.

The Farm Watch system was still in operation but to be successful requires incidents to be reported.

Lancashire County Council have put £10 m towards their Apprenticeship scheme – There are now more than 400 apprentices in LCC.

A decision on the sale of Moor Platt will be made in the near future.

It was agreed that we continue with the Lengthsman scheme, details will be finalised with Hornby Parish Council.

Surface problems on Littledale Road would be reported and the Parish Council would seek a meeting to discuss the speed and safety issues on Fell View.

12/190 INSURANCE

Insurance has been obtained through Came & Co, brokers with Aviva at £1,184.83 per annum for a three year deal. This was agreed with the Chair and ratified at the meeting. This is now in place.

12/191 RISK ASSESSMENT

The Council has considered and assessed all risks to the Council (both financial and otherwise) and have taken steps to reduce them by means of Insurances, inspections etc.

A review of the documentation will be made.
