09/174 MINUTES OF THE PREVIOUS MEETING HELD ON 14th APRIL 2009

09/175 POLICE AND COMMUNITY TOGETHER (PACT).

Two crimes had been recorded – an assault outside the Station Hotel and a theft from Rock M'Jock. There had been logs of juvenile nuisance, speeding cars and motor cycles. The SPID speed display unit had been sited on Caton Green Road.

09/177 COUNTY & DISTRICT COUNCILLORS REPORTS

Lancaster City Council had agreed to back the Winter Gardens Project in Morecambe, with no financial commitment, although there could be conflict with the 'Platform' which may compromise the business plan.

The seat by the lay-by on Quernmore Road had been removed and the litter bin by the Station Hotel required repair.

The condition of the Footpath by Hole House Farm would be looked at. There is a hedge overhanging the pavement by Parker's Farm on Quernmore Road.

09/179 FINANCE

The Audit has been set for 3rd July. Mrs P Creswell has agreed to act as Internal Auditor once again.

It was reported that first meeting had taken place and three possible concepts had been tabled. There had been a good turn out from villagers who were keen to become involved. Lancashire Environmental Projects Team would now appoint a designer to develop the plan for Fell View and help with fund raising applications.

The Parish Council gave its commitment to the project and agreed to provide some funding.

09/181 FAIR TRADE PARISH

It was reported that the Annual Parish Meeting resolved that the Parish Council be asked to consider setting up a Fair Trade Committee for Caton and Brookhouse.

The Parish Council agreed to back the proposal and provide support as required. A local Committee to oversee the project would be set up.

09/182 WAR MEMORIAL

It was agreed to accept the quote for painting the War Memorial railings from Fairclough Woodruff at a total price of £ 280.

09/183 ALLOTMENTS

It was reported that Lancaster City Council had informed us that they cannot provide Allotments in an area covered by a Parish Council. They are able to help identify possible sites and help regarding Planning, Leases etc. One suggestion was that private land owners may wish to provide 'private allotments'.

One possible site, owned by the City Council, has been identified. This may be suitable for up to five allotments. It was a possibility that an 'Allotment Group' could lease this from the City Council.

09/185 REPORTS OF MEMBERS ON OUTSIDE BODIES

Victoria Institute – Concert by 'Chuck and Albert' well attended. The Parish Council photographs etc. would be hung shortly. A request was made to have them in the Tea Room. **Library** – A revised model for the opening of the Community and County Library was being discussed with the Institute. The Institute was now open more regularly during the day. **Twinning** – The Games Evening had raised £ 97. There will be a stall at Caton Gala selling 'Strawberries and Cream'.
